GIVE NOTICE that I or my spouse or civil partner (or a person with whom I am living as husband and wife or as if we were civil partners¹) have the following.

Disclosable Pecuniary Interests²

Employment

Any employment, office, trade, profession, or vocation carried on for profit or gain. Any unpaid directorship.

Employed by Ensco 1506 Ltd (director of the same and other group companies)

Sponsorship

Any payment or provision of any other financial benefit (other than from the council) made to the councillor during the previous 12-month period for expenses incurred by him/her in carrying out his/her duties as a councillor or towards his/her election expenses. This includes any payment or financial benefit from a trade union within the meaning of the Trade Union and Labour Relations (Consolidation) Act 1992.

Any contract made between me or my spouse/partner (or a firm in which that person is a partner or an incorporated body of which that person is a director* or a body that that person has a
